



# Agreement Of Release, Assumption Of Risk And Waiver Of Liability

This agreement is between SHScutsIT, Sean Leamy, Sonora High School, Sonora High Cosmetology, Wigs for Kids (collectively "the organizers") and the individual whose name is printed and signed below as well as their parents or guardians if applicable.

I, \_\_\_\_\_ hereby agree to the following,

1. I am freely choosing to participate in SHScutsIT, a hair donation drive organized by Sonora High senior Sean Leamy supported by the Sonora High Cosmetology program and in support of Wigs for Kids, a Section 501(c)(3) charitable organization.
2. I understand that it is my responsibility to communicate the amount of my donation with my assigned student stylist, that time and space constraints only allow for a cut and not a full style and that the amount of hair cut and the resulting style may vary from my expectations.
3. I recognize that my participation may have some risk and I agree to assume the full responsibility for any risks, injuries, damages (known or unknown) or loss of any kind which I may incur as a result of participating.
4. I knowingly, voluntarily, and expressly waive any claims I may have against the organizers for any injuries, damages (known or unknown) or loss of any kind that I may sustain as a result of participating.
5. This is a legally binding Release, Waiver, Discharge and Covenant Not to Sue (collectively "Release") the organizers for any injury, damages (known or unknown) or loss of any kind caused by my voluntary participation.
6. I hereby grant the organizers permission to capture and use my likeness in photographs or video in any and all publications, including websites, without payment or any other consideration. I understand and agree that these materials will become the property of the organizers and will not be returned. I hereby irrevocably authorize the organizers to edit, alter, copy, exhibit, publish, or distribute these materials for purposes of publicizing the event or any other lawful purpose. In addition, I waive the right to inspect or approve the finished product including physical or electronic copy, wherein my likeness appears. Additionally, I waive any rights to royalties or other compensation arising or related to the use of the materials. I hereby hold harmless and release and forever discharge the organizers from all claims, demands, and causes of action which I, my heirs, representatives, executors, administrators or any other persons acting on my behalf or on behalf of my estate have or may have by reason of this authorization.
